MaineHousing's Home Accessibility & Repair Program

pays for professional home repair and accessibility changes. Homeowners must meet certain income guidelines. Professional contractors in your area do the work on your home. MaineHousing approves these contractors.

Home Repair Grant: MaineHousing can give up to **\$30,000** to eligible households. Grant funds are for necessary improvements. This includes energy-related repairs or improvements. It also includes structural repairs.

Emergency Grant: This grant is for up to **\$15,000**. It is to help with emergency issues such as no heat in the winter, severe roof leaks, and dangerous electric systems.

Accessibility Grant: This grant is for up to **\$15,000**. It is to help make a home more accessible and safe for someone with a physical disability.

Repairs may include:

Well repairs or replacements

Heating and electrical system repairs

Roof and chimney repairs

Structural repairs

Repair or replacement of windows and doors

Energy efficiency improvements

Repair or replacement of siding

Accessibility improvements for people with disabilities or physical barriers

To get help from the Home Accessibility & Repair Program:

You must own and have lived in the single family home that will be renovated or repaired.

You must own and live in the home for at least one (1) year before you apply.

Everyone listed on the property deed must sign the program paperwork. They have to sign even if they do not live in the home.

You must meet certain income guidelines. Find the guidelines at mainehousing.org/homerepair.
