I. HOME Final Rule Effective Date Delayed

The effective date of the new HOME Final Rule has been delayed until April 20th by the current administration. The delay was pursuant to a memorandum issued on January 20th requiring agencies to freeze and review any new or pending regulatory actions. If that review finds no issues of “fact, law or policy” with the rule, it could be allowed to go into effect as of April 20th.

II. Asset Management Staffing Changes

Asset Management has been through a reorganization and some significant staffing changes over the last year which has resulted in a shuffling of the assigned portfolio and contacts. Owners and Managers impacted by these changes would have received an introductory letter from the new Asset Manager.

The latest change to the department involves the Director Bob Conroy, who after 35 years of service to the agency, retired effective January 31st. The position is currently being reviewed but in the interim, Portfolio Managers Kimberly Whitley (kwhitley@mainehousing.org) and Wendy Bonsant (Wendy.Bonsant@mainehousing.org) continue to be available to answer any questions and provide guidance.

III. HUD Releases FY 2025 Operating Cost Adjustment Factors (OCAF)

The Operating Cost Adjustment Factors (OCAF) for 2025 were published in the December 11, 2024 Federal Register. These factors are used for adjusting or establishing Section 8 rents under the Multifamily Assisted Housing Reform and Affordability Act of 1997 (MAHRA), as amended, for projects assisted with Section 8 Housing Assistance Payments. The factors are effective February 11, 2025 and can be found at [Federal Register Volume 89, No 238 \(99893\)](#).

The OCAF for Maine is 3.6.
