Scope of Work Includes:

- Insulation installation: cellulose, rigid board, spray foam, fiberglass
- Building envelope air sealing
- Heat duct air sealing
- Ground cover/vapor barrier installation
- Installation of exhaust ventilation
- Minor incidental and structural repairs
- Minor electrical and plumbing repairs
- Limited diagnostic testing

- Septic systems
- Wells
- Doors/windows
