## **I. PURPOSE OF THIS RFP**

Maine State Housing Authority (MaineHousing) is an independent quasi-state agency. The mission of MaineHousing is to assist Maine people in obtaining and maintaining quality affordable housing and services suitable to their housing needs. Additional information concerning MaineHousing can be found at [www.mainehousing.org](http://www.mainehousing.org).

MaineHousing's First Generation Homebuyer Pilot Program is a mortgage program for borrowers who have never lived in a home owned by their biological parents or legal guardians. The program is also available to borrowers who have been in foster care at some point in their childhood.

MaineHousing is seeking qualified agencies to provide education classes to meet the financial literacy and/or homebuyer educational requirements, including home financing, the home purchase process, and home maintenance for applicants of the First Generation Homebuyer Pilot Program.

Providers must be able to offer translation services for class content and post-class counseling for those students with English as their second language, and must be able to evaluate and instruct students at their level of understanding and adapt their instruction methodology with sensitivity for national, cultural and/or religious diversity.

## **II. POPULATION TO BE SERVED**

First time homebuyers across the state who have a goal of homeownership in the future. These clients must meet one of the following:

- A. Borrower has never lived in a home owned by their biological parent or legal guardian during the borrower's lifetime, or
- B. Borrower is an individual who was in foster care at some point during their childhood.

## **III. SCOPE OF SERVICES**

At a minimum, MaineHousing's expectation is to select an Applicant to provide the following:

- A. Financial Literacy Classes offered in a variety of languages
- B. Hands on Homebuyer Education Classes offered in a variety of languages
- C. One-on-One support counseling sessions as follow up to class

## **IV. TERM OF CONTRACT**

Any contract awarded pursuant to this RFP will be for a term beginning as early as feasible after the award of the contract for a minimum of one (1) year from the contract date. MaineHousing has the sole discretion to extend the contract for up to two (2) additional one (1) year terms.

## **V. FORMAT AND DEADLINE FOR APPLICATIONS AND QUESTIONS**

All Applicants must submit the following:

- **Applicant Information Sheet in Appendix A.**
- **Applicant Certification Form in Appendix B.**
- **Scope of Work and Fee Proposal as Appendix C.**

**All applications must be submitted electronically to Craig Reynolds, no later than 5:00PM ET on June 5, 2023. Please include in the subject line of the email “First Generation Homebuyer Education Classes”.**

Questions concerning this RFP must be directed to Craig Reynolds by email as noted above no later than 5:00PM ET on May 26, 2023. Responses will be provided via email no later than 5:00 PM ET on May 30, 2023.

## **VI. SELECTION CRITERIA**

No formal scoring of applications will be done. Submissions will be reviewed and evaluated by MaineHousing based on its assessment of each Applicant’s capacity to meet the Scope of Services outlined herein. Upon such review, MaineHousing may schedule interviews with select Applicants. Any contract awarded by MaineHousing will be based on applications deemed by MaineHousing to be most advantageous, taking into account the factors described in this RFP.

## **VII. ADDITIONAL TERMS AND CONDITIONS**

This RFP is subject to the following terms and conditions:

- MaineHousing expressly reserves the right to modify or withdraw this RFP at any time, whether before or after any applications have been submitted or received, to correct or amend the RFP, including to adjust the timetable for this RFP, as deemed necessary. MaineHousing will not be liable for any costs incurred as a result of changes to this RFP.
- MaineHousing reserves the right to reject and not consider any or all Applicants who do not meet the requirements of this RFP, including but not limited to incomplete applications and/or applications offering alternate or non-requested services.
- MaineHousing reserves the right to waive informalities and minor irregularities in applications received.
- MaineHousing reserves the right to negotiate price or other factors included in any application submitted.
- MaineHousing reserves the right to reject any or all applications and not to award funding pursuant to this RFP, or to terminate the RFP process at any time, if deemed to be in its best interest.
- MaineHousing reserves the right to negotiate directly with one Vendor if the responses to this RFP demonstrate a lack of competition.
- In no event will any obligations of any kind be enforceable against MaineHousing unless and until a written contract is entered into.
- Each Applicant agrees to bear all costs and expenses of his or her application and there will be no reimbursement for any costs and expenses relating to the preparation of applications submitted or for any costs or expenses incurred during negotiations.
- This RFP and the successful applications, as may be modified pursuant to this RFP, will be incorporated by reference into and be part of any contract between MaineHousing and the Applicant. Information submitted by an Applicant in any application becomes public information, and is subject to disclosure in accordance with the requirements of law, including without limitation the Maine Freedom of Access Act, 1 M.R.S.A. Section 401 et seq. ("FOAA"), except as provided therein. Applicants acknowledge that MaineHousing is required to comply with FOAA.
- The Applicant, any principal or affiliate of the Applicant, or anyone who will be paid for work on the Contract, that has business ties, familial relations, or other close personal relations with a current MaineHousing employee or a commissioner, or anyone who was a MaineHousing employee or a

commissioner within the past year must disclose this information under **Appendix A – Applicant Information Sheet**.

- As a mandatory requirement of this RFP, all Applicants must complete and submit the Applicant Certification Form attached to this Notice as **Appendix B**, along with their application submission.
- Applicants shall maintain in trust and confidence and shall not disclose to any third party, except as such disclosure may be authorized in writing in advance by MaineHousing, and shall not use for any unauthorized purpose, any and all information, documents and data received or obtained from or on behalf of MaineHousing. Applicants may use such information, documents and data only to the extent required for the purposes described in this RFP. Applicants shall adhere to all security, confidentiality and nondisclosure policies and procedures required by MaineHousing for the protection of such information and data from unauthorized use and disclosure and from loss.
- Protests of any award made pursuant to this RFP must be submitted in writing to MaineHousing at 26 Edison Drive, Augusta, ME 04330, Attn: Director. To be considered, protests must be received by MaineHousing within fifteen (15) calendar days from the date of notification of the contract award and provide specific reasons and any supporting documentation for the protest.
- Applicants may not discriminate on the basis of race, color, religion, sex, sexual orientation, gender identity or expression, national origin, ancestry, physical or mental disability, age, familial status or receipt of public assistance in the admission or access to or treatment in its programs and activities.
- Women and minority owned businesses are encouraged to apply. To subcontract any of the work, Vendor must follow the steps outlined in 2 CFR 200.321.
